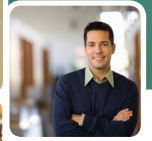

### Monitor Organizational Performance

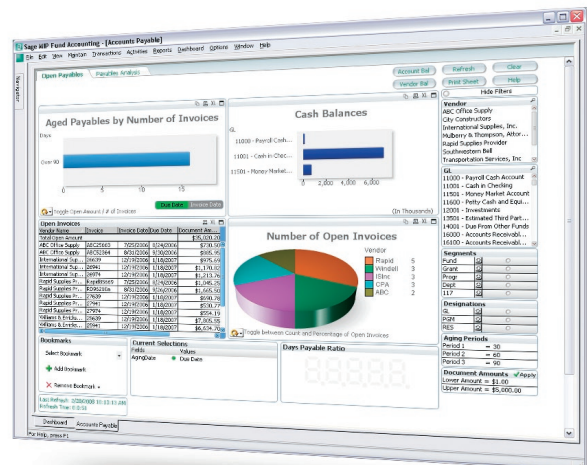
