- Excellent audit trails and transaction reporting to reduce time spent tracking specific transactions.

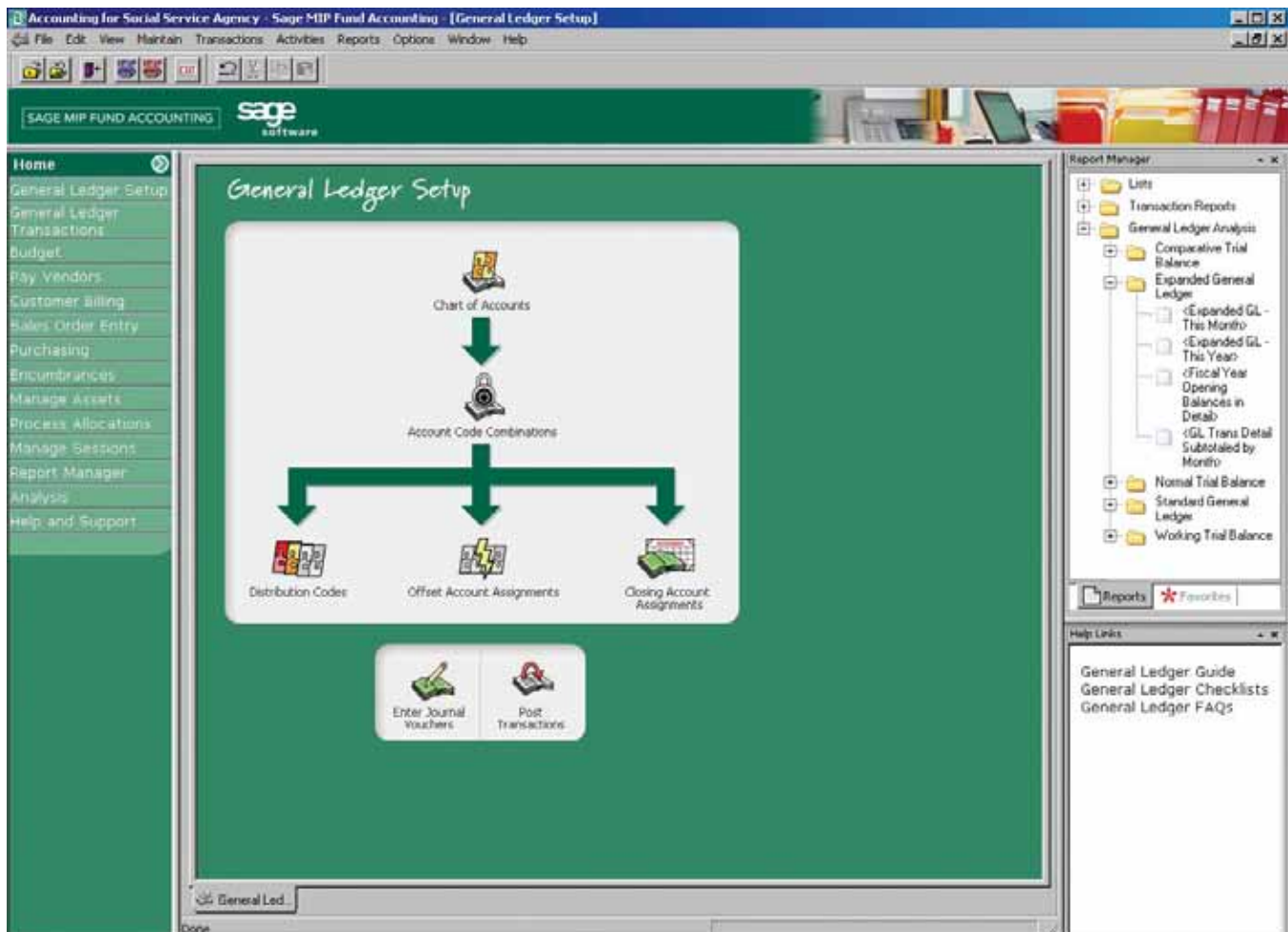
